- "the competency themes, organization, and content of the framework"
- "differentiated capabilities for learners, digital citizens and educators"
- "the Open Education Resource Repository, informed by this framework"
- "the discovery of my superpowers aligned to the framework"
- "how broad it is so it isn't specifically focused on one technology but can likely include many new ones that will arise, such as generative AI"
- "that digital literacy encompasses many different aspects such as a person's digital footprint and respecting indigenous knowledge and protocols"



- "how post-secondary institutions will ensure digital literacy is weaved into curriculum"
- "how the government will ensure support is provided to those instructors who aim to weave digital literacy into their courses and who aim to adopt open pedagogies."
- "if an institutional model can be developed as modules and then be incorporated into courses and/or programs, ensuring all learners have access to a consistent experience?"
- "about accountability for digital literacy. Where does the accountability lie, especially in educational institutions? Is it on the institution to recognize gaps in literacy, or is it left to individual educators?"



## Activity

#### **Implementation Considerations**

- Start with learning outcomes
- Use "Plus One" thinking; make small incremental changes
- Model digital literacy
- Build policies & supports at *course-level, program-level, institution-level, province-level*

- Evaluation: Describe how you will measure the success of your integration efforts. Consider what indicators will show that digital literacy is being effectively integrated into your teaching practice.
