Activity Instructions and Schedule

Week 4 – Collaboration

Overview

This week, we will be facilitating our collaborative group work looking at team dynamics and issues that can arise during collaborative online work. FLO has provided us with a readymade case study that we'll use as a springboard for our discussion. We'll use this case study to think about and share ideas from two perspectives:

- **Putting out fires**: We'll talk about a "first steps" perspective, discussing ways to resolve the immediate problem in the case study.
- **Preventing conflagration**: Next, we'll look at ways to prevent these kinds of problems from happening in the first place, or at least to prevent small problems from becoming big problems. This will be the "In the Future" perspective

At the end of this week, we hope that we will all be able to:

- recognize team dynamics that affect collaborative learning groups, and
- propose different strategies to support collaborative teams.

Readings and Resources

Please start by reading the case study, <u>Team in Trouble</u>. You can find the case study in Week 4. As you are reading, think about these questions:

- Why did this conflict occur?
- How could the facilitator respond to Sam? To Pat?
- What should the next step be?
- Who is responsible for solving this problem?
- How might this conflict impact the group dynamics?
